# 90 Day Follow Up



The 90 Day follow up for ENOS is carried out by Sharon Ellender for centres in UK and the Republic of Ireland, from the International Coordinating Centre in Nottingham. There are 16 Follow Up Coordinators at the National Coordinating Centres (NCCs) around the world that carry out follow ups internationally.

Follow up is carried out at 90 days, +/- 7 days by telephone assessment (or very occasionally by postal form). A check is always made beforehand to ensure that patient is still living and the contact details are current. Telephone follow-up lasts 5-15 minutes, dependant on who (either patient or carer) is answering the questions. The data is then entered onto the ENOS website.

#### Key issues:

- All patient details need to be received at NCC, at least 1 month prior to follow up date.
- Ensure that the 'patient details form' is complete, accurate, and updated.
- Ensure that the patient can be contacted at day 90 by telephone.
- Avoid randomising patients that are on holiday, non resident workers, or patients who cannot be contacted at day 90.
- All SAEs need to be entered by day 90.

Telephone follow ups are preferable, as we can then assess cognition, MOOD, TICs and MMSE, which would be omitted on the postal form. We have occasionally carried out a clinic visit if necessary (more usually international centres). We have recently had a few patients withdraw from the trial, which is unusual. However, we still make contact at day 90 to obtain what information is available.

We are finding that collecting contact data is becoming more of a challenge and we urge all centres to try and ensure the correct contact details and several addresses (patient and relative where possible) are given at the time of randomisation. Patients should not be randomised into the trial if they do not agree to be followed up at 90 days, as we cannot then obtain the primary outcome.
